Direction of Use

Drip/Drench: Use 10 - 20 L/acre 4-5 times per season. If used in conjunction with granular fertilizers, use 1-2 times per growing season.

Foliar: Use 4 - 8 L/acre.

Greenhouse: 1.5 - 3.5 EC based on crop need and growth stage.

Note: Rinse lines after each use in drip.
